First hearings held for the Resolution Copper **Draft Environmental Impact Statement**

The Tonto National Forest conducted the third of five public hearings regarding the Resolution Copper Draft EIS in Kearny on Tuesday, Sept. 17. The fourth hearing was held in Globe on Sept. 19. The public comment period began on Aug. 9, 2019 when the Tonto National Forest released the statement to the public online. This began the 90day comment period which will end on Nov. 7, 2019.

The hearing started with an hour long sign in period and open house. During the sign in period those wishing to make verbal comments registered and received a number. During the open house members of the Tonto National Forest Staff and SWCA. SWCA is the environmental firm that conducted the the research and studies which are presented in the Draft **Environmental Impact** Statement.

Following the Open House the Tonto National Forest presented a 15-minute video that explained the process and presented some of the data that was found in the plan. The video can be watched online:http://bit.ly/ ResolutionDEIS

The public comment period at the Kearny meeting included comments from young adults from the Town of Oueen Creek who asked that the Forest Service consider more regenerative types of growth and to protect the community of Dripping Springs or at least make sure those residents are relocated. Several Superior residents who are members of the Retired Miners and Concerned Citizens coalition spoke on the length of the DEIS.

Henry Munoz of Superior asked why the USGS was not consulted in this document. A resident of Dripping Springs expressed his concerns about water in and the potential losses

of water in their area due to the proposed tailings site. One resident of Tucson commented that it was unfair that a public hearing was not held in Tucson regarding the DEIS for Resolution Copper;

Folks were encouraged to ask questions at the third hearing on the Resolution Copper Draft Environmental Impact Statement held last week in Kearny.

Superior returns to form, crushes Mogollon

Now, that's more like it.

A week after its head coach said it had "too many mental errors and not nearly enough discipline," the Superior football team played perhaps its best game of the season, so far, last Friday night, defeating visiting Mogollon, 52 – 14.

"We executed well," Panthers head coach Ryan Palmer told the Superior Sun. "Our mental focus and intensity were solid. We played our best game of the season, but we still have a lot of growth to make."

The Panthers entered Friday's game having given up more than 100 points in their previous two games. They allowed only 14 to a Mustangs' team that averaged nearly 50 points in its four

Defense wins championships, as the Panthers proved last year. Junior Matthew Diaz-Gonzales led the defense with 10 tackles. Daniel McConnell, who had two sacks, Navarrette, and Gabe Castillo added eight, nine, and seven tackles, respectively. The Panthers forced four turnovers, including fumble recoveries by Lopez, Diaz-Gonzales (2), and Marc Mendoza. Junior Andrew Martinez recorded an interception.

"We are starting to get healthy again, and we executed better," Palmer said about the defensive improvement. "This team can dominate when we play disciplined, assignment football. We have a long way to go to reach our goal, but this game was a huge step in the right direction. We need to build off the momentum and continue to improve every day."

The Panthers offense continues to roll, scoring more than 50 points fore the third time this season.

Sophomore quarterback Matthew Cruz threw for five touchdowns, including three to senior Sammy Lopez, who finished with a team-high seven receptions for 148 yards. Junior running back Adam Navarrette added a game-high 169 rushing yards and a pair of touchdown runs. Gabe Otero, a senior, ran for a score and caught another. Junior Joshua Marquez also had a touchdown reception in the Panthers' third win of the year.

The Panthers need to maintain their focus this week; a challenge considering it's Homecoming.

"Homecoming is about coming together as a school, district, town and community," Palmer said. "It is a memorable event, promoting pride and unity. We have a lot to be proud of here at Superior, and we look forward to continuing our tradition of excellence. Tradition is important, and our team will be focused on building upon the standard set by our alumni."

The Superior Panthers will play Lincoln Preparatory Academy for their homecoming game.


St. Francis 2019 Fiestas draws large crowd



Rainwater collector improves safety along the Arizona Trail near Superior

Hiking, biking or horseback riding along the Arizona National Scenic Trail (AZT) has always been a challenge. Through deserts, canyons, mountains and forests, the AZT climbs and descends over 110,000 feet in 800 miles between Mexico and Utah. Ask anyone who has completed the entire trail — either all at once or one segment at a time — and they'll tell you the single most important factor on the trail is water...or lack thereof.

In an effort to fulfill our mission to "protect, maintain, enhance, promote and sustain the Arizona Trail as a unique encounter with the land," the Arizona Trail Association (ATA) has been researching and investing in numerous projects to enhance water sources. This includes rehabilitating springs negatively impacted by erosion; identifying and signing water sources within one-half-mile of the trail; installing bear boxes so trail users can cache gallon jugs of water in advance of their trip; and most recently, construction of a remote rainwater collector. The AZT Rainwater Collector is a unique design

that was developed by the ATA and metalsmith extraordinaire Rob Bauer in consultation with sustainability professionals, land managers and engineers. It features a steel apron that catches rainwater and stores the precious resource within a 1,500-gallon tank that is protected on all sides by steel panels. A spigot with an automatic shutoff valve allows trail users to fill and filter their bottles. Once the tank is full, an overflow pipe fills a steel water trough nearby for the benefit of wildlife. On Aug. 31, a dedicated crew of staff and volunteers braved the searing summer heat to install the very first one – halfway between reliable water sources at the Gila River and a windmill near Picketpost Trailhead.

This particular 21-mile segment has been daunting for many hikers, runners and mountain bikers. Covering the distance without any shade or water is prohibitive for equestrians whose animals require 5-7 gallons of fresh water per day. This has been the site of many Search and Rescue operations when trail users get into trouble from dehydration and heat exhaustion.

"I'm confident the AZT Rainwater Collector will save lives," said ATA Assistant Trail Director Zach MacDonald. "The Arizona Trail south of

Superior features one of the most beautiful landscapes in Arizona, but it has proven to be dangerous for many trail users. As springs and seeps dry up or are compromised near the AZT, we are committed to improving water resources for the benefit of trail users, wildlife, and the ecosystem itself. After all, a trail without water is unsustainable," he said.

The rainwater collector sits at ground level and no disturbance was necessary for its installation. unlike wildlife water projects that require a large footprint and significant ground disturbance. It will likely fill during summer monsoons for trail users to tap into during the busy autumn trail season. Then the pattern will be repeated with winter moisture refilling the tank for the spring season. The entire unit is fenced to keep livestock out, and posted signs inform trail users that the water must be filtered before consumption.

Since rainwater is essentially distilled and the unit features a three-stage screen system, it's unlikely any natural contaminants will find their way into the storage tank. The water never receives direct sunlight, so algae will not grow. Unlike most dirt tanks, ponds, streams, seeps and other sources along the Arizona Trail, cattle will have no opportunity to contaminate the water. Fine mesh screens cover the intake and outflow to prevent mosquitoes, bees and other insects from accessing the water source. Water quality will be studied over a period of one year by the University of Arizona's Project Harvest participants, and results will be shared on the ATA website.

Tremendous thanks to everyone who helped make the first AZT Rainwater Collector a success, including the Tonto National Forest; the Town of Superior's Mayor Mila Besich and Councilmember Bruce Armitage; and all of the volunteers who helped install the rainwater collector under very challenging conditions. The project was funded by a Restoration and Resilience Grant from the National Environmental Education Foundation (NEEF) and Freeport-McMoRan Copper & Gold Foundation.
