Leaving his patriotic duty to our country on June 13, 1977 with rank of SSG E6 he returned to Kearny, lived in California for a short time and eventually moved to Vernon in the White Mountains of Arizona where he has spent the last 30 plus years.

Dale married three times and loved all of them. His love of the outdoors led him to fishing and hunting. Favorite saying was "I want to go drown a worm." He was kind hearted and generous (to a fault). He lived a wonderful life and always did it his way.







This will be a long process, but a good one. There will be many opportunities for public input.

A topic for another day is the work of the tourism group which has been meeting in Kearny, aiming for ways to make the Copper Basin a destination for visitors. It's a good bunch of people taking on important work.
