She graduated from Emerson High School, Gary, Indiana in 1937 and received a three-year nursing diploma from St. Mary's Hospital,

Gary, Indiana in 1941.

She was known in the community as the head nurse at Magma Copper Company, San Manuel Division. She began her career at San Manuel Hospital in 1956 and retired from there in 1981. Her duties included working in the emergency room and the obstetrical patient's delivery



She worked in many facets of the medical field. Her previous nursing experience included working at Sacramento County Hospital; Magma Copper, Superior Division; Phelps Dodge, Ajo, AZ; St. Vincent's Hospital, Los Angeles; Veterans Hospital, San Fernando Valley, CA; and private duty.

She served in the Army from 1943 to 1945 as a nurse with the rank of second lieutenant. While stationed in Guam she was one of the first nurses to administer a

penicillin injection.

She joins her sisters Mary Vogel and Patricia Wells, brother-in-law Joe Vogel, and brothers Bernard Fitzpatrick and Jackie Fitzpatrick.

Fitz is survived by one brother James Fitzpatrick, Hawthorne, CA and many nieces and nephews including Alicia and Armando Carrillo and Charlene Acevedo.

Slump in global economy - layoffs hit local area

Sept. 1, the first day of the last quarter of 2015, Copper is selling at \$2.31 a pound and 381 mine workers are looking for a new job.

Last week both ASARCO and Freeport McMoRan made announcements that they would lay off workers and reduce production at their operations in the Copper Corridor. The recent crumbling of the stock market in China has reduced the prices for commodities like copper and oil. This has left most investors worried and the trickle down effect of the slump in China has affected the main industry of the Copper Corridor.

ASARCO plans to shut down the concentrator at Hayden indefinitely and will reduce its stripping and leaching output. This reduction affected 211 jobs at the Ray Pit and Hayden operations. Freeport McMoRan will reduce its production and is expected to lay off 170 from Miami pit operations. The rod plant and smelter will not be affected by the reduction as this time.

It is unknown at this time if the majority of those laid off were from the Copper Corridor area or if they were workers from the metropolitan areas.

Following the announcements of the lay offs, Ray Unified School district announced that anyone with students at RUSD who was affected by the lay offs should go to the cafeteria to apply for the free and reduced lunch program. Pinal County and the Department of Economic Security have many resources to help those who may be looking for assistance during this time.

Layoffs and a Special Meeting

espite a major stock correction this past week, economic indicators remain positive for upward employment figures in the United States. But that is cold comfort for the Copper Basin since it was revealed that the condenser operation at the Hayden ASARCO operations will close in October with a loss of 130 jobs and 78 people learned this weekend that they will be laid off from the leaching operation at the Ray Mine. Layoffs and restructurings are not new to us, but these announcements follow the layoffs earlier this year.

Let's hope that the price of copper will rise. Freeport McMoran is planning layoffs in Miami's open pit in response to the drop in value of copper. We're not alone in this but, again, having company in our loss is not much comfort.

Let's all help each other as much as we can. I remind citizens that the Kearny Library is part of the Arizona Workforce program. Help is available at the library with resumes, and dedicated computers will assist with job searches. There is no fee for this service. Additionally, at the urging of some citizens, I am asking for help in developing a job fair for temporary or full-time positions. Please e-mail me at sam_hosler@msn.com (that's an underscore and not a dash) if you would like to help pull this together as soon as possible.

Things are very busy at Town Hall. The scheduled audit begins this week, dealing not only with figures but with auditing procedures. Lobos get first win under new coach

New, and former, Hayden head coach John Estrada said before the season started that he wanted "to get it back to the way it was years back" at Hayden.

Well, he and the Lobos certainly looked like they're headed that direction after last Friday's 60 – 21 victory at Arete Prep.

Running backs Brandon Cruz and Ryan Donovan combined for more than 200

rushing yards and six touchdowns in the victory, which Estrada said was dedicated to injured Lobo Santiago Píña. Junior quarterback John Henry Gaona

Junior quarterback John Henry Gaona completed 7 of 12 passes for 175 yards with two passing and two rushing touchdowns. His two touchdown passes were to Mike Guerrero, a junior, who finished with 111 receiving yards on just four receptions.

Donovan led the Lobos' defense with five tackles. Guerrero and freshman Omar Lopez each had three tackles in the game.

The Lobos will play their second-straight game on the road this week, traveling to face seventh-ranked Valley Union on Friday. The Blue Devils defeated Ray last week, 56 – 0.

Grant Writing 101

handful of lucky people had an opportunity to learn everything you need to know to get started writing grants.

On Monday, Aug. 24, Cathy Melvin, who works in State District 1 Representative Ann Kirkpatrick's office, provided an intense introductory workshop about writing grants. The class was hosted by the Superior Chamber of Commerce in its new building on Main Street. Some attendees drove from as far away as San Manuel, which demonstrates the rising importance of the need for grant writers. With the price of copper falling as China's economy slows down, towns, schools, civic organizations and arts groups are all looking for ways improve their funding options by applying for grants.

Melvin provided a wide-ranging set of slides titled "Grant Writing 101." The first thing to do is make a plan that accurately reflects the needs and capabilities of your particular organization. You need to identify specific items that your group needs. Then you do research through a variety of grant-related search engines

to match an advertised grant with your specific needs. If you discover a match, your work is just beginning.

A grant Request for Proposal, or RFP, usually provides itemized restrictions about what the grant money will be used for, and also has a very detail-oriented application process. It's important to pick the right RFP to go after, because there is a lot of work involved. It's also important to have some "outside eyes" to proof read your application.

Melvin shared some insights from her personal grant writing experience. Sometimes, she explained, it's worth the effort to build up a grant proposal even if you can't meet the deadline, because when that grant comes up next year, you will be better prepared to build a winning response.

Another key item is that modern grants typically do not provide up-front cash for a project. Usually the organization needs to win the grant, use their own money to do all the work, and then apply for reimbursement. This puts a high value on an organization's ability to get

all the work done on time, and be able to document each aspect that qualifies for reimbursement. Arizona does not have a great track record for completing grantfunded projects on time, so our state sometimes sends money back because it wasn't spent in time to qualify for reimbursement.

Melvin provided copies of the slides as well as a detailed seven-page handout about how to prepare a competitive grant proposal. She also recommended a 47-page PDF file that is available on Representative Kirkpatrick's web site at: http://1.usa.gov/1Kp1Zbe.

There is also an organization called The Grantsmanship Center that offers training to people who want to become more professional and successful in their quest for grant funding. https://www.tgci.com/


