# CASA of Arizona celebrates 35 years; volunteers have been changing children's lives in Arizona since 1985

(Gila County, Ariz.— Sep. 25, 2020) Court Appointed Special Advocates (CASAs) have been standing up for children in Arizona's foster care system for 35 years. CASA volunteers are everyday people who get to know the kids to whom they are appointed, talk with everyone involved in the case and help judges identify the best outcome for the child. More than 25,000 children in Arizona have benefitted from having a CASA volunteer on their side.

The CASA program began in Seattle, Washington in 1977 when juvenile court judge David Soukup decided he needed an unbiased source to help guide him in juvenile cases. Pima County, Arizona started the second program in the nation in 1979 and CASA of Arizona was formed in October of 1985. The Arizona legislature passed a bill in 1991 that allowed CASA of Arizona to claim 30 percent of unclaimed lottery winnings. The funding mechanism allowed CASA of Arizona to open a CASA program in all of Arizona's 15 counties.

"We're proud of the growth CASA of Arizona has experienced over 35 years," said Deidre Calcoate, Program Manager for CASA of Arizona. "We have such dedicated volunteers who are changing the lives of children who have experienced abuse and/or neglect. This is not easy work, but we know it is important work. In a system that is so overwhelmed, our volunteers provide an extra set of eyes and ears for juvenile judges who make life changing decisions for children in out of home care."





### Oracle District Extends Online Learning

Our Governing Board recently voted to continue distance learning at Mountain Vista K-8 School after our return from Fall Break on Tuesday, Oct. 13. This unanimous decision was not made quickly, easily, or without consideration of each possible alternative. Our Governing Board and I agree that traditional in-person learning is the

best option for instruction, interaction, and interventions. It is our goal to resume traditional in-person learning at Mountain Vista K-8 School soon and when it is safe to do so.

The alternatives to distance learning are hybrid learning and traditional in-person learning. Many districts in our state will soon transition to hybrid learning. We agree that hybrid learning (an instruction model where half of the students attend school in-person while the other half of the students engage in distance learning and then each student group switches to in-person or distance learning on opposite days of the week) has its benefits. We also agree that hybrid learning includes a multitude of changes, challenges, and downsides that we do not want to require our staff and students to endure if not absolutely necessary.

We recognize that the continuation of distance learning may present a hardship for families who advocated for a transition to hybrid learning in our online survey during the week of Sept. 14. To meet the needs of students in need



of improved internet service, supervision, or support during the school day, we will expand our Cares Program and accommodate more students when we return from Fall Break.

We will continue to monitor the metrics established by the Arizona Department of Health and county health departments. Our Governing Board will reassess if a transition to traditional in- person learning will be safe during our October Governing Board Meeting on Thursday, Oct. 15, 2020 at 6 p.m. in the school cafeteria. If the number of positive COVID-19 cases in our community start to rise before the October Governing Board Meeting, our Governing Board will reassess a transition to traditional in-person learning during the November Governing Board Meeting on Thursday, Nov. 19 at 6 p.m. in the school cafeteria. Our staff and community are welcome and encouraged to attend the meetings of our Governing Board on the third Thursday of each month.

Our maintenance and custodial teams are working each day to prepare our campus for the return of students. When students return for traditional in-person learning, we will have touchfree hand soap and paper towel dispensers in each restroom, water bottle filling stations in place of drinking fountains on the playgrounds, hand sanitizer dispensers throughout campus, additional picnic tables for outdoor seating, a surplus of cleaning products to ensure the sanitation for surface areas, high quality air filters in each HVAC unit on campus, and both signage and training to help our students learn to consistently wash their hands properly.

When we return for traditional in-person learning we will continue to require students and staff who are sick to stay home. We will continue to use technology including Google Classroom to share assignments with students who are at home sick and work to make absences from school due to illness less of an academic hardship than they were before the COVID-19 school closures. When children become sick at school, we ask that they be picked up by a parent, guardian, or emergency contact as soon as possible.

If a family does not plan to send their child to campus for traditional in-person learning this school year, I will ask that they reach out to my office directly at 520-896-3074 before Monday, Oct. 12, 2020. We will work together to create an educational plan for each child and will assign a "teacher of record" and online curriculum to support each child. We do not plan for our teachers to teach both distance learning and traditional in-person students simultaneously. Families that request continued distance learning options beyond our transition back to campus will be accommodated with online curriculum options for the remainder of the school year.

I'm enthusiastic to see the number of positive COVID-19 cases decrease in Arizona. I'm hopeful that the measures we each make at work and at home to stop the spread of this virus will help this pandemic end soon. I'm proud of the teaching that takes place each day in our Google Classrooms and the learning that takes place in each home. I'm inspired by the resilience of our students and the commitment of our staff. I know we are unique by not transitioning to hybrid learning after Fall Break. I'm confident that we are doing the right thing by maintaining the routines we created a month ago when the school year started. We will be able to welcome students back to school soon and when we do, it will be the most wonderful day this campus has seen since March.

Copper Area News is committed to providing our readers with as much information as possible. We post a daily update on our Facebook page with the total positive COVID-19 Data. This graph shows the daily counts of positive cases for the past week as of press time on Sept. 28, 2020.

There are a few points we would like our readers to consider when following this data.

1. This will continue to be a rolling total of positive cases. It does not reflect recoveries or deaths. The Arizona Department of Health Services does not break out this data. 2. If you see a reduction in numbers from day to day it is most likely due to a data entry error or mis-coding of a zip code (at the state level). 3. This is all zip code based data; most of our zip codes include unincorporated areas. There is no way to track exactly which areas each of the positive cases are. Example, Kearny and Winkelman each have small communities in their zip code that are not in the Town's incorporated boundaries.

4. If you live in Gila County, please follow the Gila County Health and Emergency Management, Facebook. They have maintained their data on recoveries and current positive cases.


