The Hayden Town Council voted unanimously to approve the resignation of police officer Melissa Palomino. Due to Palomino's resignation the council voted to move officer

# Thank you, Unions, for Labor Day

Monday was Labor Day. The only government holiday that celebrates the accomplishments of the common man and woman, the American worker. Labor Day was first celebrated as a national holiday on June 28, 1894. It was the result of congress trying to regain the support of American workers after federal troops had been called in to end a strike that resulted in 30 American workers being killed and 57 wounded. This strike was known as the Pullman Strike.

In the 1890s the labor movement had become increasingly influential in national politics. It was not easy and many workers had struggled and even sacrificed their lives for the labor movement. That struggle and sacrifice would continue even through today.

One of the most notable strikes involving the deaths of union workers and their families occurred in the coal fields of Ludlow, Colo. in 1914. In that strike the United Mine

Workers of America protested dangerous working conditions and the rate of pay which was tied into the amount of material mined rather than the work involved. The mining companies immediately removed the strikers and their families from company housing. The union then set up tent camps for the strikers and families. The National Guard was called in to keep the peace during the strike. The mining companies were allowed to form their own militia. The company guards started a firefight that would result in the deaths of 21 people including two innocent women and 11 children. Three of the dead were militia men. This became known as the Ludlow Massacre. It would lead to what is known as the Colorado Coalfield War considered the 'deadliest strike in United States history'. The miners retaliated for the massacre after arming themselves. They attacked 10 mines in the area. Between 69 and 199 people died in the gun battles that followed. The strike would eventually end after the union

depleted all their funds. The miners did not win anything but many of them would continue to work for worker's rights.

In the 1930s the unions made steady progress thanks to President Roosevelt's New Deal policies. Many of their gains were lost after World War II and the passing of the Taft-Hartley Act in 1947 which contained numerous measures to weaken unions. In 1954 union membership peaked at 35 percent of the work force. Today it is around 12 percent. Union membership in the private sector continues to decrease. Many corporations and conservative politicians typically Republicans have sought to demonize unions and weaken their political influence since the majority of union members tend to vote Democrat. Since 1967 as union numbers dwindled so too has middle class earnings. Before you consider that unions have out lived their purpose as conservative pundits would want the people to believe, remember the

## FROM THE OFFICE OF THE GILA COUNTY TREASURER

In late fall 2012 the Gila County Treasurers office was notified that our existing property tax program was becoming obsolete and would not have a maintenance agreement after December 31, 2012. Gila County does not have on staff a computer programmer who could write such a program, so a decision was made to submit to the public for bid a contract for a new tax system.

After thorough research for the best product and price, a choice was made and the contract was approved by the Board of Supervisors in the spring of 2013. Since that time, the Treasurers' office has been working with this firm on the conversion process of moving all the data from the old system to the new one. The time consuming job of proofing approximately 50,000 secured and unsecured tax records data for the prior seven years is still ongoing. Unfortunately, the technological firm we are working with has just informed the Gila County Treasurer that the date to provide data to the printer for the printing of our 2013 tax bills is going to be later than we hoped despite the many months we have expended in this process.

The Treasurer wishes to inform the public that the 2013 property tax bills will not be mailed in September this year, but as soon as they can be made available. The delinquency date will be moved to accommodate the late mailing. We do not expect the delay to be very long. We are in frequent contact with the printer to ensure we will have top priority when we are ready.

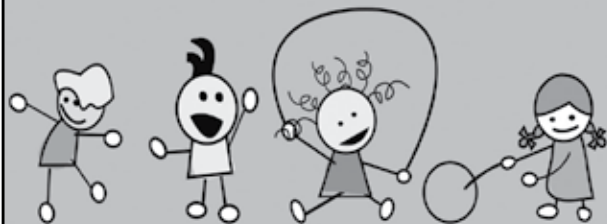

# Mustangs trample Lobos in first home game

The Lobo coaches had the team go through numerous tackling drills and even more drills on their offensive blocking techniques. They were busy drilling the team on the importance of good offensive blocks and good defensive tackles. That all seemed to go out the window Friday in the Lobos first game of the season against a highly regarded Mogollon High School team. Poor tackling and more poor tackling coupled the many blocking assignment mistakes led to the disappointing 6 to 48 loss to the mustangs.

It did not take long for the Mustangs to take advantage of the Lobo's tackling mistakes scoring on their first possession. They took the opening kick-off to the 40-yard line and three plays later scored from 48 yards out at 11:18 of the first quarter. The extra point was stopped giving Mogollon a 0-6 lead. The Lobos took the ensuing kick-off but had to punt the ball away after three plays. The punt was short giving the football to the Mustangs at the Lobo 39-yard line. Six plays later and numerous missed tackles led to a 25-yard scoring run by Mogollon's swift running backs. The Lobos stopped the extra point, giving Mogollon a 0-12 lead at 6:32 of the first quarter. The Lobos took the kick-off starting a drive of their own but a holding penalty and two quarterback's sacks returned the football to the Mustangs as time ran out on the opening quarter.

The Mustangs were controlling the football and driving for another touchdown when luck finally came Hayden's way. The Mustang back mishandled the ball fumbling at the 18-yard line where the Lobos Juan Diego Hernandez recovered the fumble. After a 12-yard run by Aaron Lagunas, the Lobo



offense bugged down having to punt only to have it blocked giving the Mustangs great field position at the Lobo 24-yard line. Two plays later, again with the aid of poor tackling, the Mustangs scored on a 28-yard run. The pass for two point was knocked down giving Mogollon a 0-18 score at 4:56 of the second quarter. The Lobos took the kick-off getting stopped when a fourth down play resulted in a sack. Mogollon could not move the chains. They punted and held on as Hayden finally flexed some offensive muscle moving down the field on Aaron Lagunas runs

and a pass completion to Robert Sandoval from Jacob Manriquez. The Lobos were moving so the clock as it ran out of time ended the first half and gave the Lobos some momentum.

The second half of play stared bad for the Lobos. They took the kick-off and another quarterback sack stopped their drive forcing a punt. Matters looked like they might change when the Lobo punt was fumble by the Mustang's receiver and was recovered by the Lobos Robert Sandoval at the Mustang 35-yard line. The Lobo offense could move the ball punting again.

The Mustangs took over at their 20-yard line moving the football down the field and finally scoring on a 35-yard run. Again they were aided by missed tackles. They scored the two points on a pass play to take a 0-26 lead at 6:06 of the third quarter. Hayden took the kick-off, could not move the chains turning the ball over a fourth down incomplete pass. It did not take long for the Mustangs to score getting a 51-yard run for a score at 2:11 of the third quarter and a pass for two points gave the Mustangs a 0-34 lead. The Lobos again, took the kick-off and could



not move the chains and had to punt. Mogollon took over at the Hayden 45-yard line; a couple of missed tackles aided a 35-yard run giving the Mustangs a first and goal at the 10-yard line. The third quarter ended with the Lobos stopping a run for a 4-yard

The fourth quarter started with the Mustang quarterback finding an open receiver in the end zone for a 14-yard scoring pass. They converted on a two point pass giving the Mustangs a 0 to 42 lead and a running clock for the game. The Lobos took the kick-off to the Mustang's 41-yard line.



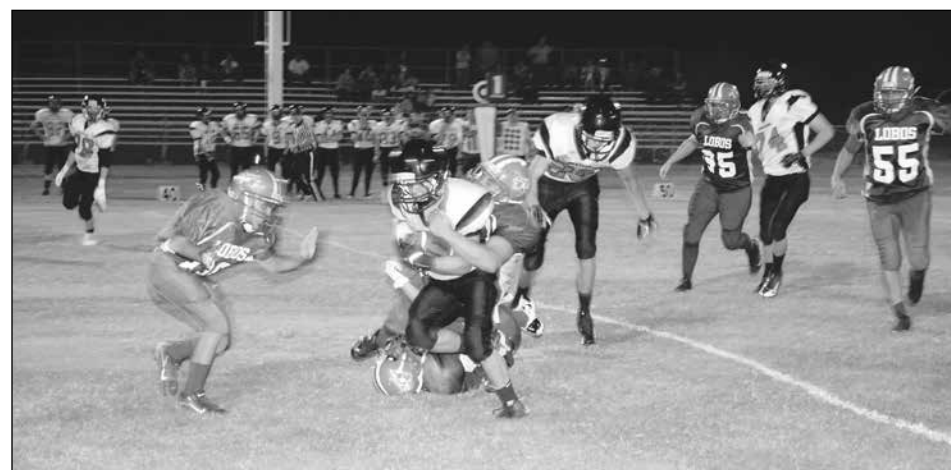




After a loss of two yards, Manriquez completed a 14-yard pass to Chris Rabago. On the next play, Manriquez found Lagunas open for a short pass with Lagunas doing the rest on a 47-yard scoring pass. The two point Lobo try was stopped with the score 6-42 at 9:40 of the fourth quarter. The lobo defense finally played liked they were taught holding the Mustangs on three negative yard runs. In punt formation at the 25-yard line, the Mustangs did not punt instead they completed a pass that would take the football to the Hayden 2-yard line. After a run resulted in a loss of 7 yards, in came their speedy running back. He took the football over the goal line and with the two point play stopped the Mustangs. They had a 6-48 lead with 6:10 on the clock. The game came to an end with the Lobos unable

to complete their pass plays. The game was not a good one for the Lobos and the stats showed the domination by the Mustangs. Hayden totaled 122 yards of offense to the 441 yards for Mogollon. Aaron Lagunas lead the offense with 63 rushing yards on 13 carries and caught one pass for 47 yards with a score. Ezekeil Boltarez carried 15 times for 18 yards. Jacob Manriquez suffered seven sacks and had a negative 40 yards. He completed five passes on 12 attempts for 81 yards and a touchdown. Boltarez had two receptions for six yards, Robert Sandoval caught one pass for 13 yards and Chris Rabago had one reception for 14 yards. On defense, Francisco Moreno lead the way with nine tackles. Brandon Cruz had a busy night in the backfield recording seven

tackles with Lagunas getting six tackles. Sandoval had five tackles and a recovered a fumble. Getting three tackles a piece were Manny Armenta, Manriquez, and Juan Diego Hernandez, who also recovered two fumbles. Boltarez had two tackles with Alex Sims, Austin White, Adrian Encinas and Santiago Pina each getting a tackle. The Lobos now will regroup, shore up their weakness and get ready for the Patagonia High School Lobos this coming Friday, Sept. 6. The Hayden Lobos will also be dedicating their playing field in honor of Robert Lorona Sr., a very respected coach and educator at Hayden. The Lobos will now be playing on the Robert Lorona Field at Lalo A. Serrano Stadium. Also on the agenda will be a tribute to the 1972 Lobo state champs led by Robert Lorona.

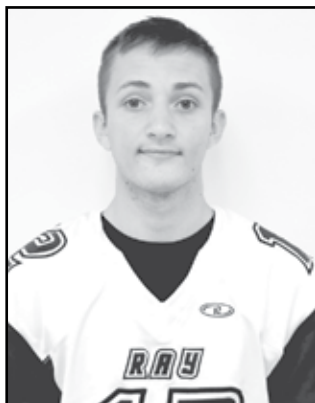

# Ray Bearcats triumph over Phoenix Day School, 52-28

Friday night for the Bearcats consisted of rain, lightning, and plenty of points as they stormed into Roadrunner territory and came away with the victory. The Bearcats dominated the first half putting up 38 points and allowing just six. Joe Rudy Lorona was in for injured quarterback Destry Yocum. He scored the first and only touchdown of the first quarter on a keeper from 8 yards out. The two point pass from Lorona to Dominic Bravo gave the Bearcats a 6-0 lead going into the second quarter of play.

The Bearcats did not take long to extend the lead as punt returner Bravo got his first of four touchdowns of the night taking the Roadrunner punt 50 yards for the score. Nick Lara converted the two point attempt giving the Bearcats a 16-0 lead with 10:24 remaining in the half. After being held to no yards on the ensuing possession, the Roadrunners were forced to punt the ball away. After a 25-yard return by Bravo

to the 18-yard line, the Bearcat offense took the field. Running back Lara took the handoff on the first play and found the end zone for his first touchdown of the year. The two point attempt by Paul Michael Wormwood gave the Bearcats a 24-0 with 7:27 left in the quarter. Starting from their own 30-yard line the Roadrunners put together a six play drive capped by a 10-yard run for their first score of the game. The two point attempt failed leaving the Roadrunners trailing by 18. With 4:51 remaining in the first half, the Bearcats relied on their passing game as new quarterback Seth Harmon connected with Bravo on passes of 25 and 12 yards to put the Bearcats in 38-6 halftime lead.

Scoring for the Bearcats did not slow down as Bravo took the opening kickoff of the second half 75 yards for his fourth touchdown of the game. The two point conversion by Wormwood gave the Bearcats a 46-6 lead. The Bearcats added another score with time winding down in the third as Wormwood

crossed the goal line with 3 minutes left to give the Bearcats a commanding 52-6 lead heading into the final quarter of play.

With a comfortable lead coach Willie Jordan gave way to the younger players on the Bearcat team giving them some experience at the varsity level. Although they gave up a few points the younger Bearcats did an amazing

job both offensively and defensively. At the end the Bearcats walked away with a 52-28 win and a 2-0 start to the season.

The Bearcats did an excellent job on both sides of the ball. Offensively Harmon threw three passes for 35 yards and two touchdowns. Robin Newman ran for 80 yards, Lorona ran for 15 yards and one touchdown,

Wormwood ran for 12 yards and one touchdown. On the receiving end Bravo made three catches for 52 yards and two touchdowns.

Defensively the Bearcats were led by defensive end Ryan Bickley who had six tackles, three assists and one sack. Rexx Sosa and Bravo each had five tackles with Sosa recording a sack. Wormwood, Julio Noriega,

Jordan and Jacob Pace recorded four tackles each with Jordan Pace recording a sack.

The Bearcats will be idle this week but will return to action on the 13th as they will play their first home game against the Lobos of Patagonia. This is an exciting Bearcat team to watch so come out and show your support for these young athletes.

Asarco has stated that this facility is required to support continued long-term copper mining activities at the Ray Mine. Tailings from the Ray Mine concentrator would be transported via a new tailings pipeline that would cross the Gila River near the current Florence-Kelvin highway bridge. Water would be recycled back to the Ray Mine concentrator from the proposed tailings storage facility. The proposed facility is designed to store approximately 750 million tons of tailings and would have a facility footprint of approximately 2.129 acres once completed. The two public open house meetings will allow interested parties to learn more about Asarco's plans, the Corps' regulatory obligations under its 404 permit process, and the plans and schedule for completion of an EIS for the proposed project.
