Beginning of school year often reveals child abuse, neglect

The end of summer and the start of a new school year is an exciting time for most children. But for some, the beginning of school could reveal a dark secret when signs of abuse and neglect these children have suffered over the summer are noticed by teachers, staff and other parents.

“Because children are subject to less adult supervision over the summer, it’s not uncommon for reports of suspected abuse and neglect to spike at the start of the school year,” states Patti Dremler, CASA Coordinator of Northern Gila County.

Many of the children who are confirmed as victims are removed from their homes and placed into foster care—often far from their friends, families and schools. CASA (Court Appointed Special Advocates) volunteers from CASA of Gila County are specially screened and trained to speak up for abused and neglected children who, through no fault of their own, end up in the foster care system.

“Being uprooted from their homes and families is scary for these children. We at CASA want to make sure that they do not get lost in the overburdened foster care system,” Dremler states. “For that reason, we need more people in our community to speak up and make sure these children’s voices are heard. We want to help ensure that their stay in foster care is as short as possible and that they are placed in safe, loving homes quickly so they can begin to heal.”

There are 110 children in the child protection system in Gila County, and only 18 CASA volunteers to advocate for their best interests.

“Too many children are forced to go through the chaos of moving through the child protection system alone,” Dremler said. “CASA of Gila County needs more volunteers to step up and be a voice for children who desperately need them.”

Joanie King has been a CASA volunteer for 2 years. As a CASA volunteer she advocates for children’s needs in court and in the child welfare system. She helps them through their struggles in foster care. Joanie’s main objective is to help the children obtain the services they need to help them heal from the trauma they experienced and to feel loved and safe.

“We need more dedicated CASA volunteers like Joanie to walk with children every step of the way and ensure

that they are placed into safe, permanent homes as quickly as possible,” Dremler said.

This school year, become a CASA volunteer and help

Local area sees increase in bed bug activity

Bed bugs.

The name alone can cause shudders of revulsion.

They are just so icky.

While there has been an increase of bed bug activity reported in the Copper Basin area, the Pinal County Health Department reported that the good news is they don't transmit infectious diseases. The only time the department does step in is when bed bugs are reported at hotels.

Graham Briggs, a Pinal County Health Department official who works in the

infectious diseases office, recommends that if a homeowner has noticed bed bug activity, they should call a licensed pest remediation company.

"Call pest control," he suggests.

The health department doesn't track bed bug complaints, but it has seen an uptick in complaints. Briggs explained that this uptick is in line with what is happening nationally. It's pretty much everywhere, he said.

According to the Centers for Disease Control:

What are bed bugs?

Bed bugs (*Cimex lectularius*) are small, flat, parasitic insects that feed solely on the blood of people and animals while they sleep. Bed bugs are reddish-brown in color, wingless, range from 1mm to 7mm (roughly the size of Lincoln's head on a penny), and can live several months without a blood meal.

Where are bed bugs found?

Bed bugs are found across the globe from North and South America, to Africa, Asia and Europe. Although the presence of bed bugs has traditionally been seen as a problem in developing countries, it has recently been spreading rapidly in parts of the United States, Canada, the United Kingdom, and other parts of Europe. Bed bugs have been found in five-star hotels and resorts and their presence is not determined by the cleanliness of the living conditions where they are found.

Bed bug infestations usually occur around or near the areas where people sleep. These areas include apartments, shelters, rooming houses, hotels, cruise ships, buses, trains, and dorm rooms. They hide during the day in places such as seams of mattresses, box springs, bed frames, headboards, dresser tables, inside cracks or crevices, behind wallpaper, or any other clutter or objects around a bed. Bed bugs have been shown to be able to travel over 100 feet in a night but tend to live within 8 feet of where people sleep.

Do bed bugs spread disease?

Bed bugs are not known to spread disease.

Bed bugs can be an annoyance because their presence may cause itching and loss of sleep. Sometimes the itching can lead to excessive scratching that can sometimes increase the chance of a secondary skin infection.

What health risks do bed bugs pose?

A bed bug bite affects each person differently. Bite responses can range from an absence of any physical signs of the bite, to a small bite mark, to a serious allergic reaction. Bed bugs are not considered to be dangerous; however, an allergic reaction to several bites may need medical attention.

What are the signs and symptoms of a bed bug infestation?

One of the easiest ways to identify a bed bug infestation is by the tell-tale bite marks on the face, neck, arms, hands, or any other body parts while sleeping. However, these bite marks may take as long as 14 days to develop in some people so it is important to look for other clues when determining if bed bugs have infested an area. These signs include:

- the bed bugs' exoskeletons after molting,
- bed bugs in the fold of mattresses and sheets,
- rusty-colored blood spots due to their blood-filled fecal material that they excrete on the mattress or nearby furniture, and a sweet musty odor.

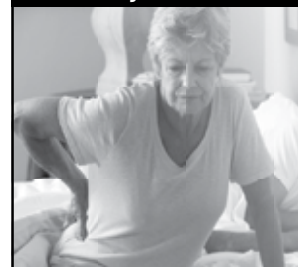

Blessed Sacrament to host annual Fiesta

It's time for the annual Blessed Sacrament Church Fiesta, when great music, food, friends and fun blend together to create a pleasant day flowing into an exciting evening. Which is as true as it has been, year after year, sometimes with the help of the weather and sometimes in spite of it.

People come from all over the Copper Corridor to attend this event, which commemorates the ringing of church bell by Roman Catholic Priest Miguel Hidalgo y Costilla on Sept. 16, 1810, which began the call to arms that began the Mexican War of Independence. This happened in the town of Dolores in the state of Guanajuato.

In October 1825 this day became known as Mexican Independence Day. While the exact words and give or take between Hidalgo and the crowd during the Grito de Dolores (Cry of Dolores) are a matter of debate, the spirit of the message was an opposition to bad government and a call to adhere to their faith. This cry of independence has become an integral part of the celebration of Mexico's Independence Day.

On the night of Sept. 15, at 11 p.m., the President of Mexico rings the very same bell, but, from the National Palace in Mexico City. After each ringing of the bell, he then repeats a cry of patriotism based on the Grito de Dolores, known as a Grito Mexicano. This will include the names of important heroes of the Mexican War of Independence who were present during the original bell ringing and end with the threefold shout of "Viva, Mexico!"

The following day is Fiesta Patrias (Patriot Festival), also

Learning a Little About Aravaipa Creek

Like so many rancher families, the Fred and Cliff Wood families had experienced both good and bad times when they had their Wood Brothers Panorama Ranch whose headquarters was located along the western end of Aravaipa Creek in Pinal County, Arizona. The children of both families had also taken part in the hard work involved, and the memories of those earlier years are treasured.

Many changes concerning Aravaipa Creek and some of its residents had started in the 1960s. Aravaipa Canyon had become more well-known because of the publicity to "save it", so many people wanted to come to the canyon, and those who had come through the west end had to first go through our ranch homesite along the creek to see the inner canyon, known as the Box, which wasn't far upstream of our home. In 1966, the Bureau of Land Management (BLM) wanted the inner canyon to be set aside as a Natural Scenic Recreation Area, and then in 1969 the over five-thousand acre Aravaipa Canyon Primitive Area was established, and BLM's plan was to coordinate recreation, grazing, and other public uses, besides wildlife management.

Naturally, our lives were really affected, so in 1970 we sold our ranch to The Nature Conservancy (TNC), the national conservation organization who claimed their primary objective was to acquire and protect outstanding natural areas. It was

in 1978 that Wilderness designation of the Aravaipa Primitive Area and contiguous lands had been recommended.

I have often wondered what our lives would have been like if we hadn't sold our ranch when we did. For those who are interested in learning about some of the history of Aravaipa Canyon and some of the people who had lived there, read my 2014 published book *A CREEKSIDE STORY - FROM BUCKBOARD DAYS TO ECOTOURISM*.
