## New ADOT policy allows approved memorials along highways; plan promotes safety for families, motorists and ADOT personnel

PHOENIX – Recognizing the need of families to grieve in different ways for those killed in crashes, the Arizona Department of Transportation has established a policy allowing memorial markers along state-maintained highways in a way that minimizes risks for motorists, families and ADOT personnel.

Developed with input from community members, the policy specifies a maximum size and establishes standards for materials and placement so markers present less chance of distracting passing drivers or damaging vehicles leaving the roadway.

“We have heard the concerns shared with us and developed this way for families to honor loved ones, and we’ve done it in a way that promotes safety,” ADOT Director John Halikowski said. “Those who have already

placed memorials can work with us to keep tributes that meet these requirements and to replace those that don’t.”

A family or its designee should submit a request to the ADOT engineering and maintenance district serving a particular area, providing the intended design and location of a marker honoring a relative killed in a crash. District officials will review requests to make sure they meet requirements including:

- **Size and materials:** A marker may be up to 30 inches high and 18 inches wide, and the wood or plastic/composite material components used to create it may be up to 2 inches thick and 4 inches wide. It may include a plaque up to 4 inches by 4 inches and up to 1/16 of an inch thick. It may be anchored up to 12 inches in the ground, but not in concrete or metal footings.
- **Placement:** In consultation with ADOT officials, families will place markers as close as possible to the outer edge of the highway right of way. Markers may only be placed in front of developed property if the property owner gives written permission to the family.

Memorials already along highways may remain if they meet safety standards for placement, size and materials. However, those who placed them must contact the ADOT district office serving that area and identify themselves as contacts should the memorials ever have to be moved.

Memorials that haven’t been approved by ADOT or that don’t meet the policy’s safety standards for placement,

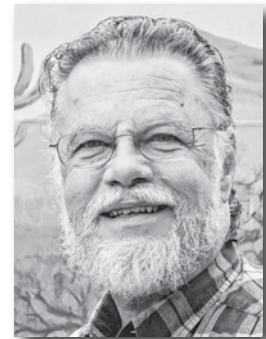

# Babeu coattails shrink as Henry and Voyles lose to Lamb and Volkmer in August 30 primary

## Superior voters remove Valenzuela from office, elect Besich-Lira as Mayor

Pinal County voters spoke on Aug. 30 in the Arizona Primary Election, and their words were anything but pleasant for County Attorney Lando Voyles, District 2 Supervisor Cheryl Chase, Superior Mayor Jayme Valenzuela and Kearny Mayor Sam Hosler. All four saw their terms of office cut short at the ballot box.

And while the Town Councils of Kearny, Mammoth and Superior will see plenty of new faces as a result of the Aug. 30 election, on the county level voters mostly renominated incumbents to represent their parties on the Nov. 8 ballot.

One trend from the primary election is that the political muscle of two-term Pinal County Sheriff Paul Babeu may be on the wane. While he won the Republican nomination over five other candidates in the First Congressional District with 32.5% of the vote, the candidates Babeu endorsed did not fare as well.

Mark Lamb, a former Pinal County Deputy (2012-14) and Detective with the Salt River Police Department, easily defeated Babeu's Chief Deputy Steve Henry for the Republican nomination for Pinal County Sheriff. And Kent Volkmer, president of the Pinal County Bar Association, beat Babeu loyalist and incumbent Lando Voyles by more than 5,000 votes for the Republican nomination for Pinal

County Attorney.

Henry and Voyles ran an extensive campaign as the "Law and Order Team," blanketing county roads with groups of signs touting the criminal threats to the county before reaching their joint poster in a manner reminiscent of the Burma Shave advertising campaign of yore. But voters opted for the quitter separate campaigns of Lamb and Volkmer. Lamb did especially well among voters in San Tan Valley where his campaign signs were not seen before homes on subdivision streets.

Lamb will face Kaye Dickson, who convincingly won the Democrat nomination for Sheriff over Kevin Taylor. Dickson campaigned hard on programs to prevent crime and promises to be a working rather than a showboat sheriff.

Babeu will face Democrat Tom O'Halleran to succeed U.S. Senate candidate Ann Kirkpatrick as Congressman in Arizona's First District, which stretches from southern Pinal County to the far northeast corner of the state. Although O'Halleran won the Democrat nomination by more than 7,000 votes throughout the district, his opponent Miguel Olivas topped him by 400 votes in Pinal County.

Among incumbent members of the Pinal County Board of Supervisors, only Cheryl Chase was not renominated by voters. Mike Goodman, a San Tan Valley resident and owner of several local businesses, finished first in a field of five candidates in the Republican Primary with 1,726 votes (33.8% of the total votes cast). Chase placed second with 1,390 (27.1%), followed by Tisha Castillo, Wayne Bachmann and Manuel R. Vega.

Goodman's win was credited to his hard personal campaigning especially in San Tan Valley, where he promised to help bring more jobs and services. Also a supporter of San Tan Valley incorporation, Goodman will face no opposition in November as there is no official Democrat candidate slated.

In other Pinal County Board of Supervisor races, renominated incumbents nominated are Democrat Peter Rios (District 1), Stephen Miller (District 3), Anthony Smith (District 4) and Todd House (District 5). Only Rios will face competition in November from Republican Thomas Sorensen, who ran unopposed for his party's nomination. The other three face no competition in November as the Democrat Party fielded no candidates in

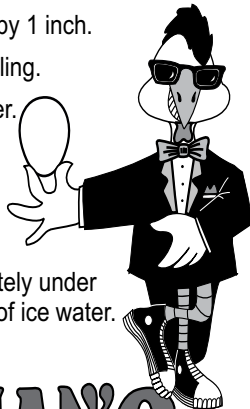

# Winkelman Wastewater Treatment Plant earns accolades

The Town of Winkelman was awarded the Wastewater Treatment Center of the Year award after making upgrades to its facility when it was found to be non-compliant with state regulations.

Many of these upgrades had to be done as they did not comply with the operating permit Winkelman had.

In a letter to Vern Camp, the RWAA Executive Director, from the Mayor of Winkelman, Louis C. Bracamonte, the mayor writes that the town received federal funding to get the necessary materials to upgrade the facilities old parts.

These upgrades included:

- Modification of piping for RAS and denitrifications
- Construction of drying beds
- Installation of a new back-up generator
- Installation of a continuous flow meter device.

Included in the initial letter from the mayor was a request that the two operators of the Wastewater Treatment Facility, Arthur Monterde and John Wallestad, be recognized for their work and improvements to the facility.

“Many hours of hard work have been demanded of them, and as of this date, they have achieved all the requirements of ADEQ (Arizona Department of Environmental Quality),” the letter states. “It is my desire that these two individuals be recognized and that WTPP be recognized for their improvements on the plant.”

Sam Polk, a Wastewater Specialist from the Rural Water Association of Arizona, came to Winkelman to help train operators in the area on the skills they needed to help keep the waste water treatment center up to regulations, according to a letter written to Camp from Gloria Ruiz, Winkelman’s Deputy Town Clerk.

He helped train them on the new equipment and to maintain the regulations they worked to achieve.

Polk said over a phone interview that once he was in Winkelman and got to talking to the people there, they developed a trust and were able to open up to him on what problems the facility was having.

“They built a friendship and trust with me to the point where I was able to train them and assist them in their non-compliance issues,” he said.

He also said that the Rural Water Association receives a list of places that are non-compliant and that representatives are sent out to help those that need it.

Polk said the association offers free assistance to water treatment plants.

“We make various stops and offer our assistance at no charge,” he said.

Polk also discussed that each waste water treatment plant is assigned their corresponding permits from three different agencies. The Environmental Protection Agency, Arizona Department of Environmental Quality and Arizona Department of Health Services.

“There are quite a bit of protocols to stay in compliance (with the permits),” he said.

Some of the protocols include maintaining bio-solids and meeting regulations on sewage discharge.

Polk said in regards to how awards are given out, representatives are sent out to see who can be nominated to be a potential winner.

“There are representatives throughout Arizona that screen and select the nominations,” he said.

## Loss for Hayden: Lobo defense good enough, offense isn't

The Hayden football team entered last Friday night's game against NFL YET Academy looking to slow an offense that averaged 64 points per game in its first two games of the season, both of them

wins.

The Lobos' defense did its part, holding the Eagles to less than half their season average, but the offense was absent, leading to a 28 – 6 loss at home.

"Our defense did really well," Hayden head coach John Estrada told the Copper Basin News. "We held them, but we need

to get our offense clicking."

The Lobos were shut out in the loss, their lone score coming on defense – a pick six by senior Brandon Cruz. The offense has scored only six points in two games, which is not enough output if winning is the goal.

"We have to make some adjustments and keep pushing forward," Estrada said about

the Lobos' offense. "Hopefully, these next two games we can do better. Everyone just has to do their jobs."

After two home games to start the season, the Lobos will play the next two on the road, beginning at Ft. Thomas this Friday.

Kickoff is scheduled for 7 p.m.

## Bearcats pick up first win of the season

The Ray football team turned the tables last Friday night at Ft. Thomas and pick up its first win of the season as a result, spoiling the Apaches home opener and coming way with a 68 – 12 victory.

The Bearcats, who had surrendered an average of 59 points per game in their first two games, limited the Apaches to only 12 points thanks to an improved defensive effort.

"We've made some strides, but we're still not there," Ray head coach Frank Lechuga said about the Cats' defense. "They're two touchdowns came on passes, where we had some blown coverages."

Sophomore Jaden Pace, who was named the Offensive Player of the Game, threw for three touchdowns and rushed for three more to lead the Cats' offensive juggernaut. Fabian Valenzuela finished with two touchdown receptions and a rushing touchdown while senior running back Paul Wormwood added a rushing

score.

"We spread the ball around and got our passing game into the attack," Lechuga told the Copper Basin News. "We finally had that two-dimensional offense that we needed and we weren't relying solely on the running game. The passing game really helped out this week."

Defensively, junior Nathan Molar continued his outstanding play for the third week in a row. "He's a monster on defense," Lechuga said. After playing three-straight road games

to open their season, the Cats will finally play in front of the home fans this Friday versus Baboquivari. They'll enter the home opener with some needed confidence.

"You could tell in their eyes and the way that they carried themselves that the win helped their confidence," said Lechuga, who earned his first varsity win. "They know what they need to do to keep winning and getting that first one really helped with all the hard work they put in."

Let's hope it shows on Friday night. Friday's kickoff is scheduled for 7 p.m.

# Hayden students to use iPads in the classroom, excited by the possibilities

After many months of anticipation, Hayden High School was proud to present brand new iPads to students this week. On Aug. 30, Jeff Gregorich, school superintendent, presented Santiago Pina with the first iPad, followed by a school-wide release on Sept. 1. At the end of the school day, Gregorich beckoned all students to gather at the main area and around Pina while the honorary first iPad was presented. Jokingly, Gregorich commented on how there's no excuse for homework not to be done, to which Pina looked up at him, smiled, and said, "I forgot."

A few days later, students were called from their classrooms to finally get their own iPads. The excitement was palpable as each student was handed their very own, individual iPad, to be used how they wished. Students gathered together to look up videos and websites, not a disappointed face in the bunch.

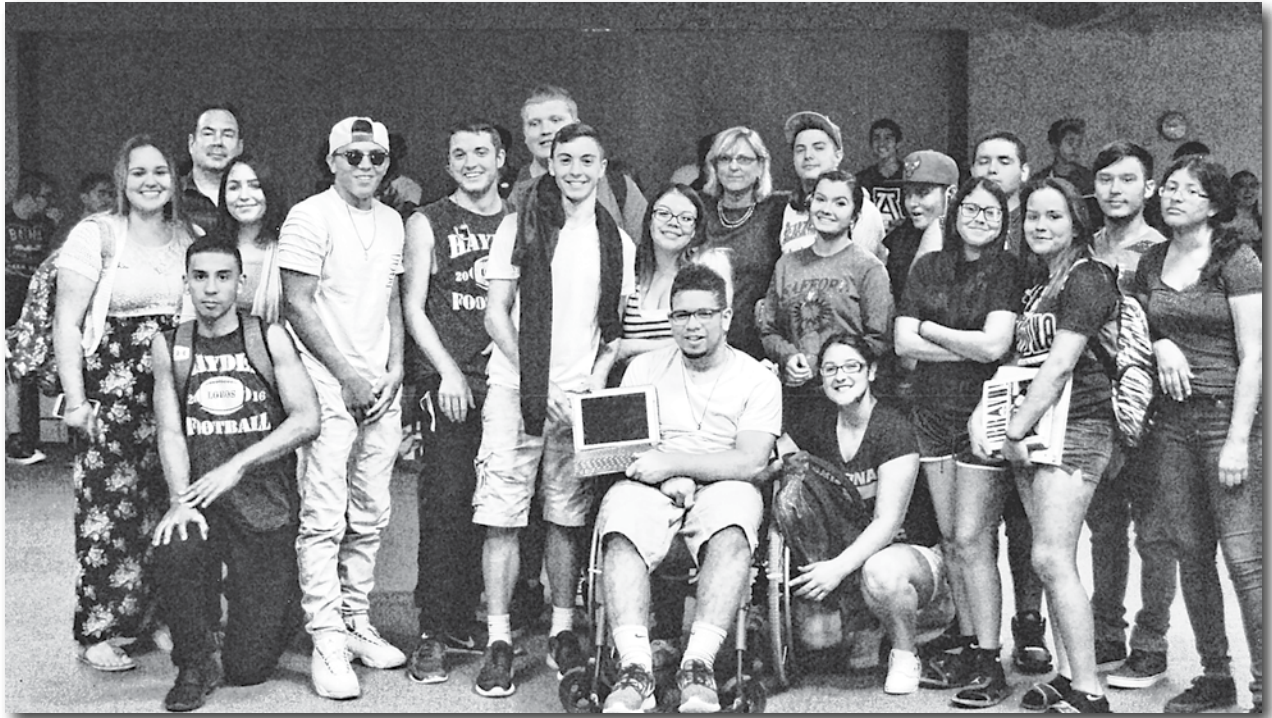
Gregorich hopes that the new iPads will not only increase student productivity, but a general sense of well-being among the students, some of whom have never even owned a cell phone, let alone technology as advanced as the iPad. Already morale has increased among students and many feel that this technology will help them not only be interested in subject material, but actually look forward to going to class and completing assignments in a way that is familiar to them. Teachers, who also get their own iPads, are just as excited as the students are. Quinn Gates, Social Studies teacher at the high school, hopes that the iPads will help the students be more engaged in the classroom.

"When they are more engaged, they are learning more," he said.

With the iPads, students are able to access the internet, take paperless notes, and create projects and presentations without ever having to leave their seats to log-in to a computer. Over the summer, Hayden increased the amount of bandwidth and installed more access points around the building to allow for better, faster internet use than the students were previously used to. This will ensure that no matter how many students are using the internet at once, it will still run smoothly and all students will be on the same page at the same time.

On the first day, some teachers allowed students to play around and get a feel for what can be accomplished using the iPads, researching related topics and taking quizzes, but most students were just as happy to use YouTube and listen to their favorite songs while completing paper lessons. However, the possibilities are endless and some teachers, like Gates, are very excited to actively put this technology to use in the classroom.

"I can use certain apps to ask questions and get instant and individual responses from my students, and there are a lot of websites, activities and games that can help the students learn and make sure they know what I want them to know," Gates told the Copper Basin News, "This saves me lots of time and paper that would otherwise be spent

creating and grading assignments."

the primary.

The local race that had everyone watching was the Recall Election for Mayor of Superior. Incumbent Mayor Jayme Valenzuela was easily ejected from office by Town Council member Mila Besich-Lira, who received 516 votes to Valenzuela's 151 votes. The recall election was called in April as nearly double the necessary citizen signatures were secured in response to the discovery last December that Valenzuela had used the town debit eight times for personal matters, including a visit to the Wild Horse Pass Casino.

Besich-Lira will assume the position of Mayor of Superior at the Sept. 8 Town Council Meeting.

Membership on Superior's Town Council also will change. Voters reelected Vice Mayor Olga D. Lopez, along with new members Vanessa Navarrette and Bruce Armitage. Incumbent John A. Tameron and Carl W. (Bill) Vogler did not receive sufficient votes.

There also will be turnover on the Town Councils of Kearny and Mammoth.

Debra Sommers nosed out incumbent Sam Hosler at Kearny Mayor by only 29 votes. However, the race was close and Sommers getting just under 50% of the vote, a runoff election could be staged in November. Whether a runoff is needed will be determined when the official election results are issued on Sept. 7, said Kearny Town Clerk Cathy Woolery.

On the Town Council, only Sheila Stephenson was reelected to a new terms. Securing the most votes for Council seats were Rose Bradford and Samantha Mista. Failing to win reelection was David Herrera.

In Mammoth, only Mayor Frances Wickham was reelected to the Town Council on Aug. 30. New Council members, all of whom received more votes than Wickham, were Alvaro Anaya, Joe Dietz and Frances Amparno. Council incumbents not reelected were Vice Mayor Joe Brewer and Bob Sloan, as was Bart Goff. In Mammoth, voters elect the Council but Council members vote among themselves as to who serves as Mayor and Vice Mayor.

Other Pinal County races decided on August 30 include only one contested race where for County Accessor incumbent Republican Douglas Wolf will face Democrat Jacqueline Minto. For the other positions Republicans will run unopposed, which are Recorder Virginia Ross, Superintendent of Schools Jill Broussard and Treasurer Michael McCord.

November matchups for State Senate seat mostly in Pinal County will be in District 8 incumbent Democrat Barbara McGuire against Republican Frank Pratt, District 11 incumbent Republican Steve Smith against Democrat Ralph Atchue, and District 16 incumbent Republican David Farnsworth against Democrat Scott Prior. For State House of Representatives seats, the matchups are in District 8 Thomas (T.J.) Shope (incumbent) and David Cook against Democrat Carmen Casillas, District 11 incumbent Republicans Mark Finchan and Vince Leach against Democrat Corin Hammond, and District 16 incumbents Kelly Townsend and Doug Coleman against Democrats Sharon Stinard and Cara Prior.
