

SUSD board extends online learning until Oct. 12

On Sept. 2 at its regular meeting, the Superior Unified School District Governing Board voted to extend remote-learning until Oct. 12. This means the teachers will continue to run their classes using Microsoft Teams as well as School PLP.

The District will also continue to provide an onsite learning option while using the remote-learning platform. The Board also adopted the benchmarks as a guide to determine in-person learning.

Pinal County Health Services reports COVID-19 benchmarks for Districts each week. Using the colors red, yellow, and green the benchmarks look at the number of cases per 100,000, the percentage of positive cases, and the percentage of COVID-like illnesses.

"All of our staff want our kids back at school but we want to be at an area that allows us to do so," said Superintendent Steve Estatico. "Being 'green' in all three categories will allow us to begin in-person learning at some level."

The Board also voted to allow the Superior High School Athletics Teams to participate in the fall sports season. The Arizona Interscholastic Association (AIA) had voted to proceed with fall sports activities using the same COVID benchmarks as well as specific guidelines to be implemented for each sport.

"We want to give our student-athletes a chance to compete but only if the benchmarks allow us to do so," Estatico said. "We are satisfied with the guidelines that the AIA established. Again, we will need to be in the 'green' in order to actually compete with other schools." Estatico said that in order for the District to get to "green" and stay "green" it will need help from the Superior Community.

"Please keep wearing your mask in public, practice social-distancing and wash your hands," he requested.

Superior Police Report

More beautiful than Sophia Lauren. Still, to this day."

This romantic vocalist and the 18-year-old beauty who captured his fancy are my mom and dad. The elusive, smart and witty unsuspecting charmer sitting in the audience and enjoying the performance that night was Dorothy Nader, who was attending the Syrian-Lebanese Society's festive annual affair. She had come with her older sister and best pal, Margo, both of whom had recently relocated to Arizona from their hometown, Detroit, Michigan, with their parents, Nadima and George Abdo Nader.

It would be almost a year following this memorable evening before Jim and Dorothy saw each other again—the occasion this time: A New Year's Eve gala on Camelback Road. Fortunately for Jim, Dorothy's date that night was mostly absent—he was in charge of organizing the evening's festivities, which gave this poor hardworker's enterprising rival (my gets-what-he-wants dad) plenty of time to display his plumage to his beguiling soon-to-be bride. If you ask Jim, here's how he says things started out:

"When I asked your mother for her number, she instructed me get it from her sister. Your mother was a stuck-up. But, Margo didn't hesitate. She gave me the number right away. She knew I was a 'catch." And the truth is, he was. My dad was—sorry, is!—tall and good looking, with a big heart and a generous spirit. A real gentleman who had to develop the skill of getting along with others as he was the middle-child of 10 Arizona-born offspring of the James Senior and Angelina Karam big, busy, well respected family.

Dorothy's memory of the first spark differs, though. "Your father never gets the story right," she says. "I told him, 'If you want my number so badly, then go look it up.' And you know your dad," she proudly continues, "he went to find a phone book, came back immediately, then rattled off my number to me." She remembers the moment with a smile—yeah, Jim was right, one that Sophia Loren could never equal.

So, on that nostalgic night, Dorothy ditched her unlucky other admirer. A twinge of guilt still lingers when she recounts this part of the story; however, she never for one second regrets the decision she made to spend the rest of the night on the dance floor with her new paramour as they waltzed, jitterbugged, fox-trotted and rhumbaed into the new year and then into their future...

...even though the poor bastard she ditched turned out to be the aviator Howard Hughes. No, just kidding. But I know she'd still have regrets, even if he was! Anyway...

...at the time, Jim was helping his dad run the family dry goods business, "Karam's," in the small mining town of Superior, Arizona. Undaunted, Jim made the 120-mile roundtrip every weekend to see his Valley of the Sun sweetheart, a courtship cut short when Jim was drafted into the Army. Under these challenging circumstances, they moved the wedding date up and got married before the groom headed valiantly off to Germany, where he would be stationed for two years, quickly moving up the ranks, undoubtedly, to Sergeant First Class.

Upon Sgt. Karam's return from Frankfurt, the couple picked up their dancing shoes and made Superior their home, where they built a thriving business, "Karam's Department Store," and raised their three pain-in-the-ass children: Cheryl, a nurse practitioner at Maricopa County Hospital; Jim, who has enjoyed a long career in financial management; and me, a busy standup comedian and T.V. performer in L.A. (And I'll be honest, I do enjoy knowing that nobody can accuse me of exaggerating when I say about the entire family that we are all truly...Superior!)

Anyway, the couple maintained an active social life, dancing in the halls and ballrooms of Superior—there's that word again!—and the entire state. They took in much of the whole country, in fact. Throughout their marriage, they traveled extensively and continue to get around to this day—pre-covid anyway—a regular highlight being meet-ups that includes lots of dancing with good friends at the Elks Club in Phoenix (where Jim, not so incidentally, has held the position of Grand Exalted Ruler) two or three nights every week.

In any case, even while busy full-time raising a family and dancing with his wife, Jim continued to sing, host, emcee, organize events, volunteer and help the community. He was District Administrator of Little League Baseball for 25 years, voted into office as member of Pinal County Community College District Governing Board, and elected to three four-year terms as member and Chairman of the Pinal County Board of Supervisors. always been a family man, a pillar of the community, while Dorothy, who never wanted any of the limelight, rode shotgun all the way. Which, his kids will tell you, explains why his answer whenever they pose a question to him, any question, is always, "Ask your mother."

Earlier this year, in February, we celebrated Jim's 92nd birthday. On hand were his two daughters, granddaughter, Alesia and great-grandson, Ashton, along with, via Facetime from California, Jim III, daughter-in-law, Karen, and their three children; Baileigh, True and Bella. Not present, however, was Brooks John, Jim and Dorothy's new great-grandson: coming soon in November! Anyway, a special request Jim made to the band at the end of the night, Jim's present to himself, was the perfectly named tune "Unforgettable" that he danced to unforgettably with his unforgettable bride.

September 10th will mark the 70th anniversary of Jim and Dorothy Karam. The last big anniversary party was held at the Elks for their 50th. This year, the loving couple planned to renew their vows with their dear friends and family on hand from out of town, but, due to covid, that happy scenario will be postponed for now. But only for now.

They're making the best of the stay-athome situation, though—they sleep in, whipping up a breakfast of eggs, oatmeal and of course fruit, then reading the Arizona Republic "cover to cover," as Jim puts it. What generally follows is an afternoon nap, some exercise (mostly indoors now with the heat!), then a refreshing shower. Covid has not interrupted Jim's daily routine of visiting his grandson Ashton and the family dog Sosh, who conveniently live two doors down, along with Alesia and Cheryl. They make or pick up dinner for their grandson, they may have a little happy hour with cocktails, chips and salsa...peppered of course with lots of passionate opinions.

High school fall sports season starts but will it finish?

The Executive Board of the Arizona Interscholastic Association voted last Wednesday to endorse guidelines proposed by its Sports Medicine Advisory Committee (SMAC) for a safe return to sport and activity. As a result, the AIA fall sports season will continue as scheduled.

However, the question remains: Will it finish? Football, the last fall sport to begin, started practice on Monday, with games scheduled to commence Sept. 30

Monday, with games scheduled to commence Sept. 30
 Oct. 2. The sport of golf has begun competition. Cross country, swimming & diving, badminton, fall soccer and volleyball have started practice and tryouts.

"I would like to say on behalf of the staff and the Sports Medicine Advisory Committee, especially for the sport of football, we would not have been able to make this decision until this time right now based on the metrics," AIA Executive Director David Hines said in a statement. "So, the metrics have gotten to a place that we can start football practice. That we can start the heat acclimatization (guidelines). That we can get kids in a helmet and shoulder pads and begin doing work."

Some teams across the state have already decided not to conduct a fall sports season, including Ray High School in Kearny, while others are still unsure if or when they will proceed. The AIA has stated "schools playing football will have the option of beginning practice on Labor Day, which is Sept. 7 with any date after that permissible."

"Per our athletic director and superintendent, we're going to push back the start of practice for two weeks," Hayden football head coach John Estrada told *Copper Area News*. "The reason for pushing that back is because our area is still in the red per the health department. If things change in two weeks and we get put in the green, then I believe they'll give us the ok to start practice. If things don't change, I'm afraid our season may be cancelled."

Superior High School returned to the practice field after suspending activities a few weeks ago.

"The SUSD school board voted last Wednesday, 5-o, for the return of high school fall sports," Panthers football head coach Ryan Palmer said in an email to *Copper Area News*. "Programs will be following the AIA guidelines and health metrics for a phased return to practice, and hopefully competition.

"I think that the guidelines, established by doctors and health officials, promote the safety of students, staff, and their families. Although nothing is ever guaranteed, I believe that by following the guidelines, we can return to sports safely. It will take a diligent effort from all involved, to make smart, safe choices, to successfully execute the season."


Starting practice, especially in team sports where socially distancing is nearly impossible, including football, volleyball, and soccer, is a positive step. The proposed



guidelines to continue toward game competition between teams remain a challenge.

The following countyspecific benchmarks, as published on the Arizona Department of Health services (ADHS) website, allow for the start of practice:

- 1. Two weeks below 100 cases per 100,000 OR twoweek decline in the number of new cases (not including current week).
- 2. Two weeks with percent positivity below 7% (not including current week). 3. Two weeks with hospital visits due to COVID-like illness below 10%.

The benchmarks to begin game competition must reach another phase, considering the SMAC guidelines assess the risk of COVID-19 spread in athletic sports settings. According to the 19-page document, the risk is expected to be increased during teambased practice, more risk within-team competition, even more risk when full competition between teams from the same local geographic area, and the highest risk during full competition between teams from different geographic

Modifications previously released by the AIA that address such game logistics of eliminating postgame handshakes, equipment sanitizing, and more aim to reduce risks, however, they don't affect the benchmarks defined by the ADHS nor the SMAC guidelines to begin game competition.

Currently, most communities are considered in the "Moderate Community Spread" category of the SMAC guidelines, which allows larger team sports and contact sports to consider non-contact team practice with cohorts at least six feet from other cohorts at practice and the following:

- Outside practice encouraged when possible
- · Maintain healthy operations and healthy environment guidelines shall be followed at all times
- · Athletes shall be kept in the same training group (cohorting)
- · Athletes should have their own equipment (i.e. helmets)
- Training drills with shared equipment may occur (i.e. sleds)
- · Cleaning and disinfecting schedule in place
- Minimum cleaning before and after each cohort, but preferred before and after each athlete
- · No close contact drills between players
- No competitions
- · All coaches and staff should wear masks at all

For competition to commence between teams, communities must reach a level of "minimal community spread" defined

- 1. <10 cases/100,000
- 2. <5% of COVID-19 PCR tests performed are positive
- 3. <5% of hospital visits due to COVID-like illness

If and when that level is reached, "all sports, with and without contact, may resume with usual activity," according the SMAC guidelines.

Many throughout the state, including coaches, parents, and media wonder if that level is unattainable in the next four weeks or less. Soccer and volleyball are scheduled to begin game competition Sept. 16-21.

The AIA appears to believe that communities will reach the level required to see games under the Friday Night Lights and

"To say we are happy to be where we are now is an understatement," Hines said. "The Board members really took their time to make sure that this could be done safely. We think that it definitely can.

With the help of everyone at our member schools doing their part, we can absolutely make this a memorable season."

No doubt, this fall sports season will be remembered but for what?

We are about to find out.

The remediation work at the old Magma West Plant has been completed and approved by the Arizona Department of Environmental Quality (ADEQ). Soil cleanup began in 2016 and wrapped up earlier this year. Since completion, hydroseeding with a native seed mix has already produced vegetation on the reclaimed mining land.


